TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release") dated as of March 27, 2013, by **BANK OF AMERICA, N.A.**, a national banking association and successor in interest to Fleet Capital Corporation (the "Lender"), to **PM BEEF HOLDINGS, L.L.C.**, a Delaware limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 31, 2004, between the Lender and the Grantor, recorded on May 18, 2004, at Reel No. 002851, Frame 0908 (as at any time amended, restated, supplemented or otherwise modified, the "Trademark Agreement"), the Grantor granted a security interest to the Lender in certain trademarks and their respective registrations and applications for registration, together with the goodwill of the business symbolized by the trademarks, all licenses relating thereto, and all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), and the right to sue for past, present and future infringements (all of which trademarks, trademark registrations, applications for registration, goodwill, licenses, proceeds and other rights are collectively called the "Trademarks"); and

WHEREAS, the Lender now desires to terminate and release the entirety of its security interest in the Trademarks;

FOR VALUE RECEIVED, including the satisfaction of all obligations, indebtedness and liabilities secured by Trademarks pursuant to the Trademark Agreement and the Loan and Security Agreement dated as of March 31, 2004 among the Lender, the Grantor and PM Beef Foods, L.L.C, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender does hereby terminate, release and discharge its security interest in, and sell, assign, transfer and convey to the Grantor, **without any representation or warranty by, or recourse to,** the Lender, all right, title and interest of the Lender in and to the Trademarks listed on Schedule A attached hereto, arising under the Trademark Agreement, and any right, title or interest of the Lender in such Trademarks shall hereby cease and become void.

This Termination and Release is intended to operate as a release of all liens and security interests conveyed by the Grantor to the Lender pursuant to the terms of the Trademark Agreement and to reassign to the Grantor all of the Lender's right, title, and interest acquired pursuant to the terms of the Trademark Agreement.

The Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.
