**AMENDED AND RESTATED
TRADEMARK SECURITY AGREEMENT**

Amended and Restated Trademark Security Agreement dated as of March 28, 2013 (as amended, restated or otherwise modified, this "Trademark Security Agreement") among LodgeNet Interactive Corporation, a Delaware corporation (the "Borrower"), the subsidiaries of the Borrower signatory hereto (such subsidiaries, together with the Borrower, the "Grantors"), and Gleacher Products Corp., as Administrative Agent for the Secured Parties (together with successors and assigns in such capacity, the "Administrative Agent").

WITNESSETH:

WHEREAS, each Grantor is party to that certain Guarantee and Collateral Agreement dated as of April 4, 2007 (the "Existing Collateral Agreement") among the Grantors, the subsidiaries of the Borrower from time to time party thereto, and the Administrative Agent, pursuant to which each Grantor executed and delivered that certain Trademark Security Agreement dated as of April 4, 2007 (the "Existing Trademark Security Agreement") in order to secure the prompt and complete payment, observance and performance of their respective obligations under that certain Credit Agreement, dated as of April 4, 2007 (as amended, restated, amended and restated, supplemented or otherwise modified immediately prior to the date hereof, the "Existing Credit Agreement"), among the Borrower, the banks, financial institutions and other entities from time to time parties thereto (the "Lenders") and the Administrative Agent;

WHEREAS, concurrently herewith, the Borrower, the Grantors party thereto, the Administrative Agent and Lenders are entering into that certain Amended and Restated Credit Agreement of even date herewith (as may be further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), in order to, among other things: (i) amend and restate the Existing Credit Agreement in its entirety and (ii) re-evidence, ratify and reaffirm the obligations which shall be repayable hereafter in accordance with the respective terms and provisions of the Credit Agreement; and

WHEREAS, each Grantor is party to an Amended and Restated Guarantee and Collateral Agreement of even date herewith (as may be further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among the Grantors, the subsidiaries of the Borrower from time to time party thereto and the Administrative Agent, pursuant to which each Grantor is required to execute and deliver this Trademark Security Agreement.

NOW, THEREFORE, in consideration of the premises and to induce the Secured Parties to enter into the Credit Agreement each Grantor hereby agrees with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Collateral Agreement and used herein have the meanings given to them in the Collateral Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. In order to secure its Obligations, each Grantor hereby assigns and transfers to the Administrative Agent, and hereby

grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

- (a) all United States and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certifications marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, and all registrations and applications for any of the foregoing, including, but not limited to: (i) the registrations and applications referred to on Schedule I hereto (collectively, "Trademarks"), (ii) all extensions or renewals of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License and (iv) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill;
- (b) any and all agreements providing for the granting of any right in or to Trademarks (whether such Grantor is licensee or licensor thereunder) including those referred to on Schedule I hereto (collectively, "Trademark Licenses"); and
- (c) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages and proceeds of suit.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent for the Secured Parties pursuant to the Collateral Agreement, and each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall control.

SECTION 4. Governing Law. This Trademark Security Agreement and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.

SECTION 5. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.


