## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 29, 2013, is made by BNY Mezzanine Partners, L.P., as agent for the Purchasers (together with its successors and assigns, the "Collateral Agent").

**WHEREAS**, The Center for Wound Healing, Inc., a Nevada corporation ("Grantor") has granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain trademarks and trademark applications and certain other property (collectively, the "Trademark Collateral"), pursuant to that certain Trademark Security Agreement dated as of December 23, 2010 (the "Trademark Security Agreement");

**WHEREAS**, the security interests granted to the Collateral Agent was recorded at the United States Patent and Trademark Office as follows: on January 3, 2011 at Reel 4445 and Frame 0355; and

**WHEREAS**, the Collateral Agent has agreed to terminate and release its security interest in all of such Trademark Collateral, including, without limitation, the Trademark Collateral identified on Schedule 1 attached hereto, and reassign the same to the Grantor.

**NOW, THEREFORE**, for valuable consideration, the Collateral Agent hereby terminates and releases all mortgages, liens, assignments and security interests granted to the Collateral Agent and conveys to the Grantor, without representation, warranty, recourse or undertaking by the Collateral Agent, all of its right, title and interest, if any, in and to the following:



2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including without limitation, any claim by the Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or (b) injury to the goodwill associated with any Trademark.
