TRADEMARK OWNERSHIP AGREEMENT

This Agreement is entered into by and between Exelis Inc., an Indiana corporation having an office at 1650 Tysons Blvd, Suite 1600, McLean Virginia 22102 ("Exelis") and Specialty Plastics, Inc., a Louisiana corporation having a place of business at 15915 Perkins Road Baton Rouge Louisiana 70884 ("SPI"), as of the date this Agreement is signed by the last-to-sign party (the "Effective Date").

WHEREAS, SPI is a wholly-owned subsidiary of Exelis;

WHEREAS, SPI has sold, and continues to sell, products and services under the names TIGERWRAP and FIBERBOND ("the Trademarks"), each of which is the subject of one or more Trademark Registrations, including the registrations identified in the attached Appendix; and

WHEREAS, Exelis and SPI wish to have a clear understanding of the ownership of rights associated with the Trademarks,

The Parties hereby agree as follows:

I. OWNERSHIP

As between Exelis and SPI, SPI is and shall remain the sole owner of the entire right, title and interest in and to the Trademarks, and Exelis hereby assigns any and all of its rights in the Trademarks, including all rights to sue for past infringement and all goodwill associated with the Trademarks that is or might be owned by Exelis, as of the Effective Date to SPI. Exelis shall provide assistance as may reasonably be necessary to prepare, sign and record documents evidencing the assignment from Exelis to SPI.

II. LICENSE RIGHTS

Under its ownership rights, SPI hereby grants to Exelis a non-exclusive, royalty-free, fully paid up, worldwide license to use the Trademarks as is reasonably necessary for Exelis to support the business of its subsidiary SPI. Should SPI be sold, divested or otherwise transferred to a new owner such that neither Exelis nor any Exelis subsidiary owns any interest in SPI, then the license rights granted hereunder shall terminate upon such sale, divestiture or transfer.

III. GENERAL PROVISIONS

This Agreement is subject to the laws of the Commonwealth of Virginia, and any disputes hereunder shall be resolved exclusively by the courts of Virginia.
