**GRANT OF SECURITY INTEREST IN TRADEMARKS**

FOR VALUABLE CONSIDERATION, the receipt and adequacy of which is acknowledged, **MONSTER, INC.**, formerly known as Monster Cable Products, Inc., a California corporation ("Grantor"), grants to COMERICA BANK, a Texas banking association in its capacity as agent under the Loan Agreement, as defined below (in such capacity, "Agent"), and the Lenders from time to time party thereto ("Lenders"), a security interest in all of Grantor's right, title and interest in and to the following whether existing now or later or in which Grantor now has or later acquires an interest, and wherever the same may be located ("Trademark Collateral"):

1. All rights, title and interest (including rights acquired pursuant to a license or otherwise, but only to the extent permitted by the agreements governing such license or other use and without resulting in the abandonment, invalidation or unenforceability of any right, title or interest of Grantor therein) in and to the following trademarks (collectively, the "Trademarks") described on Exhibit "A".
2. Any and all claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights set forth above.
3. All proceeds, products, rents and profits of or from any and all the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Agent, for and on behalf of the Lenders, is the loss payee), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise in respect of any of the foregoing Trademark Collateral. For these purposes, the term "Proceeds" includes whatever is received or receivable when any Trademark Collateral or other proceeds are sold, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

Grantor has granted the security interest under this instrument pursuant to the terms of the Amended and Restated Loan and Security Agreement dated April 20, 2007, as amended ("Loan Agreement") made by Grantor and Monster, LLC, a Nevada limited liability company, to Agent, for and on behalf of the Lenders, for the purposes of security as provided in the Loan Agreement. Grantor acknowledges and affirms that the rights, privileges and remedies of Agent with respect to the security interest in the Trademark Collateral granted in this instrument are more fully set forth in the Loan Agreement, the terms and provisions of which are incorporated in this instrument by this reference.
