TRADEMARK ASSIGNMENT

Assignor shall, without further consideration, execute any additional documents and take such further action as may be requested by Assignee to vest in Assignee good, valid, and marketable title to the Trademark Rights.


This assignment and all of the terms hereof shall be binding upon and enure to the benefit of the parties and their respective heirs, personal representatives, successors and assigns.
