RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of April 1, 2013 (the "Effective Date"), by Deutsche Bank Trust Company Americas, a New York banking corporation, in its capacity as collateral agent (in such capacity, "Grantee"), in favor of Dole Packaged Foods, LLC, a California limited liability company ("Grantor").

WHEREAS, Dole Food Company, Inc. (the "Issuer"), the guarantors party thereto and US Bank National Association ("US Bank") entered into that certain Indenture dated as of March 18, 2009 (as amended, supplemented or otherwise modified to the date hereof and as it may hereafter be amended, supplemented or otherwise modified from time to time, the "Indenture");

WHEREAS, Issuer, Grantor and certain of other subsidiaries of Issuer party thereto and US Bank entered into that certain Security Agreement dated as of March 18, 2009 (as amended, supplemented or modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Issuer, Grantor and certain other subsidiaries of Issuer entered into, in favor of US Bank, that certain Grant of Security Interest in United States Trademarks dated as of March 18, 2009, concerning the trademarks listed on Schedule 1 attached hereto (as amended, supplemented or modified from time to time, the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 20, 2009, at Reel 003956, Frame 0440;

WHEREAS, US Bank and Grantee entered into that certain Assignment of Intellectual Property Security Agreements dated as of March 21, 2011 (as amended, supplemented or modified from time to time, the "Assignment of Trademark Security Agreement"), pursuant to which, among other things, US Bank assigned all of its right, title and interest in, to and under the Trademark Security Agreement to Grantee;

WHEREAS, the Assignment of Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 31, 2011, at Reel 004512, Frame 0001; and

WHEREAS, Grantee has consented to the release of its Lien (as defined in the Indenture) on the trademarks listed on Schedule 1 attached hereto (the "Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Trademark Collateral is hereby terminated and released.
2. To the extent Grantee retains any interest in the Trademark Collateral, Grantee hereby assigns, transfers and conveys to the Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to the Trademark Collateral.
3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release at the Grantor's sole cost and expense.
