SECURITY INTEREST RELEASE AND TERMINATION

Reference is made to that certain AMENDED AND RESTATED LOAN AND SECURITY AGREEMENT (the "Loan Agreement") dated as of May 29, 2007 by and among, FORTRESS CREDIT OPPORTUNITIES I LP, a Delaware limited partnership (the "Lender"), FORTRESS CREDIT CORP. as the arranger and administrative agent for the Lenders (together with its successors and assigns, "Agent") and, on the other hand, PEER 1 NETWORK (USA) INC., a Washington corporation ("US Holdings"), and each of US Holdings' Subsidiaries (such Subsidiaries, together with US Holdings, are referred to hereinafter each individually as a "Borrower", and individually and collectively, jointly and severally, as the "Borrowers"), Peer 1 Network Enterprises, Inc. (on its own behalf and as successor by amalgamation to Peer 1 Networks Inc.), a British Columbia corporation ("Parent"), and each of Parent's Subsidiaries.

Reference is also made to that certain CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS dated as of September 2, 2005, executed by Peer 1 Networks Inc. (the "Grantor") in favor of the Agent (the "Confirmatory Grant"), pursuant to which the Grantor pledged its assets, including the trademarks and applications identified in Schedule A hereto, together with the goodwill symbolized thereby (collectively, the "Applicable Marks"), to the Agent. The Confirmatory Grant was recorded in the United States Patent & Trademark Office on September 2, 2005, at reel/frame 3154/0701.

The Agent acknowledges and confirms that the Agent's security interest in and to the Applicable Marks under the Loan Agreement and the Confirmatory Grant is terminated effective as of the date set forth below.

The Agent releases and reconveys to the Grantor, without warranty or recourse, any and all of the Agent's right, title, claim and interest in and to the Applicable Marks. The Agent hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government office to record this termination and release, including but not limited to the recording the termination and release of the Agent's security interest in the Applicable Marks.

IN WITNESS WHEREOF, the Secured Party has caused this termination to be duly executed and agreed to as of the date set forth below.
