RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, STAR MARKETS COMPANY, INC., a Massachusetts corporation ("Grantor") granted a security interest in and lien upon certain trademarks, trademark applications and related rights to Wells Fargo Bank, National Association, in its capacity as Administrative Agent ("Secured Party") as set forth in the Grant of Security Interest in United States Trademarks, dated as of August 30, 2012, by Grantor in favor of Secured Party (the "Trademark Security Agreement");

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on October 26, 2012 at Reel 4893, Frame 0619;

WHEREAS, Grantor has requested that Secured Party release and reassign its interest in (a) the trademarks and trademark applications more fully identified in Schedule A annexed hereto and made a part hereof (the "Trademarks"), (b) all rights and privileges arising under applicable law with respect to Grantor's use of any Trademarks, and all reissues, extensions, continuation and renewals thereof, (c) all prints and labels on which any Trademarks have appeared or will appear, and all designs and general intangibles of a like nature; (d) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks, and (e) all rights corresponding thereto together with the goodwill of the business symbolized thereby (collectively, the "Trademark Collateral");

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to Grantors any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in all Trademark Collateral, without recourse or representation or warranty, express or implied, of any kind; and

2. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
