Notwithstanding any other provisions of this Assignment to the contrary, nothing contained in this Assignment shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge, or in any way affect the provisions, including warranties, covenants, agreements, conditions, representations, or in general any of the rights and remedies, or any of the obligations and indemnifications of Assignors or Assignee set forth in the Asset Purchase Agreement. This Assignment is intended only to effect the transfer of certain

property transferred pursuant to the Asset Purchase Agreement and shall be governed entirely in accordance with the terms and conditions thereof.

The Assignor hereby represents that Assignor has full right and authority to convey the entire interest herein assigned, and that Assignor has not executed, and will not execute, any agreement in conflict therewith.





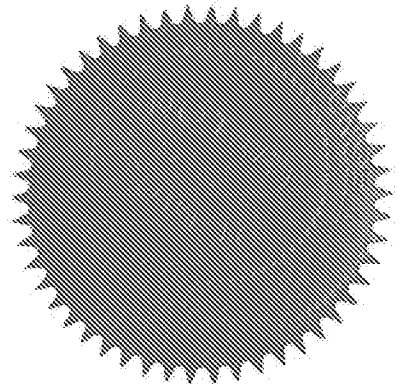
