## ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "Assignment") is made as of January 3<sup>rd</sup>, 2012, by Four Points Media Group of Salt Lake City, a Delaware corporation ("Assignor"), to Sinclair Communications, LLC, a Maryland limited liability company ("Assignee").

WHEREAS, Assignor, with a place of business at 299 South Main Street, Suite 150, Salt Lake City, UT 84107, is the owner of registrations for the trademarks that are identified in Schedule A ("Marks") and desires to assign all right, title and interest in, to and under the Marks, together with the goodwill and business symbolized thereby; and

WHEREAS, Assignee, with a place of business at 10706 Beaver Dam Road, Cockeysville, MD 21030, desires to obtain all of Assignor's right, title and interest in, to and under the Marks; and

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement"), dated as of September 8, 2011, between Assignor, Assignee (as assigned by Sinclair Television Group, Inc., a Maryland corporation) and certain other parties, Assignor has agreed to assign all of its right, title and interest in, to and under the Marks to Assignee, and Assignee has agreed to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Purchase Agreement, Assignor hereby sells, conveys, transfers, assigns and delivers to Assignee, its successors and assigns all of Assignor's right, title and interest throughout the world in perpetuity in, to and under the Marks, free of all Liens other than Permitted Liens, whether statutory or at common law, including all registrations and applications therefor, the right to sue and recover for all past, present and future infringements and other violations of the Marks, and the goodwill associated with such Marks in the operation of the Business (as defined in the Purchase Agreement), the same to be held and enjoyed by Assignee to the same extent that such would have been held and enjoyed by Assignor had this assignment not been made. Buyer hereby purchases, acquires and accepts such right, title and interest to and under the Marks.

This Assignment is intended to evidence the consummation of the transactions contemplated by the Purchase Agreement and is subject to the terms and conditions set forth in the Purchase Agreement. Assignor hereby covenants and agrees to use its commercially reasonable efforts to provide any further necessary documentation and do all further acts reasonably requested by Assignee in this regard to confirm and perfect title in and to the Marks in Assignee. This Assignment is made without representation or warranty, except as provided in or pursuant to the Purchase Agreement. Nothing contained in this Assignment shall be construed to supersede, limit or qualify any provision of the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.

This Assignment shall be binding upon, and inure to the benefit of, the parties hereto, their respective successors in interest, and their respective permitted assigns.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument.




