ASSIGNMENT OF INTANGIBLE PROPERTY

This ASSIGNMENT OF INTANGIBLE PROPERTY, dated December 1, 2012 (this "Assignment"), is entered into by and among Newport Television LLC, a Delaware limited liability company ("Newport"), Newport Television License LLC, a Delaware limited liability company ("Newport License" and together with Newport, "Assignor"), and Sinclair Media III, Inc., a Maryland corporation ("Assignee"). Each of Assignor and Assignee are collectively referred to herein as the "Parties."

WHEREAS, Assignor and Sinclair Television Group, Inc. ("Sinclair") have entered into an Asset Purchase Agreement dated July 19, 2012, (the "Purchase Agreement");

WHEREAS, by an Assignment dated as of July 19, 2012, Sinclair assigned its right to acquire the Assigned Intangible Property with respect to the operation of television broadcast station WKRC-TV, Cincinnati, Ohio to Assignee;

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to assign to Assignee all of their right, title and interest in and to the Intangible Property included in the Purchased Assets (the "Assigned Intangible Property"); and

WHEREAS, Assignor wishes to confirm Assignee's ownership of the Assigned Intangible Property and to assign to Assignee all right, title and interest that Assignor may have in and to the Assigned Intangible Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee any and all worldwide right, title and interest Assignor holds, or may hold, in and to the Assigned Intangible Property, including without limitation, the Trademarks and domain names listed on Schedule A hereto, together with all the goodwill connected therewith and symbolized thereby; the same to be used and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors and assigns to the end of the term or terms for which the Assigned Intangible Property are granted or reissued or extended as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, and in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto in and to all causes of action (either in law or in equity) and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment.
2. As of the date set forth above, the Assignee has succeeded to all right, title and standing of the Assignor to (a) receive all rights and benefits pertaining to the rights described above and (b) commence, prosecute, defend and settle all claims and take all actions that the Assignee, in its sole discretion, may elect in relation to the rights described above.
3. This Assignment is, in all events, subject to the Purchase Agreement.


4. All capitalized terms not otherwise defined in this Assignment, as used in this Assignment, will have the respective meanings set forth in the Purchase Agreement.
5. The Parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office, the United States Copyright Office, applicable domain name registrars and/or the applicable foreign authorities to record Assignee as the assignee and owner of the Assigned Intangible Property.
6. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns. This Assignment and the rights and obligations of the Parties hereunder shall be governed by, and construed in accordance with the laws of the State of Delaware. This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or e-mail shall be effective as delivery of a manually executed counterpart of this Assignment.




