"Corporation"), is hereby amended to provide that, immediately upon the Reverse Stock Split Effective Time (as defined below), every five shares of the common stock, \$0.01 par value per share (the "SLE Common Stock"), of the Corporation that were issued and outstanding immediately before the Reverse Stock Split Effective Time shall be combined into one issued and outstanding share of SLE Common Stock, \$0.05 par value per share. No fractional shares of SLE Common Stock of the Corporation shall be or remain issued upon such amendment and each stockholder Stock of the Corporation shall be or remain issued upon such amendment and each stockholder otherwise entitled to a fractional share shall be entitled to receive in lieu thereof cash in an amount otherwise entitled to a fractional share shall be entitled to receive in lieu thereof ash in an amount otherwise entitled to a fractional share shall be entitled to receive in lieu thereof ash in an amount otherwise entitled to a fractional share shall be corporation's transfer agent of all such fractional share interests.

SECOND: The amendment to the charter of the Corporation as set forth in Article FTRST above has been duly approved by a majority of the entire Board of Directors of the Corporation as required by law. Pursuant to Section 2-309(e)(2) of the Maryland General Corporation Law (the "MGCL"), no stockholder approval was required.

The amendment set forth in Article THIRD above is limited to a change expressly authorized by Section 2-605(a)(2) of the MGCL to be made without action by the stockholders of the Corporation.

FIFTH: These Articles of Amendment shall become effective at 5:00 p.m. EDT on June 28, 2012 (the "Reverse Stock Split Effective Time"), except that Article Third shall become effective immediately after the Reverse Stock Split Effective Time.

<u>SIXTH</u>: There has been no increase in the authorized stock of the Corporation effected by the amendments to the charter of the Corporation as set forth above.


