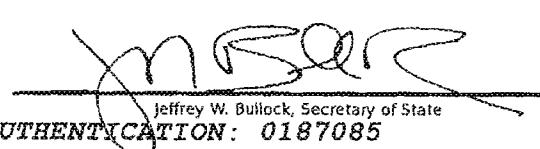

Pursuant to Section 242 of the Delaware Corporation Law of the State of Delaware, the undersigned, being the Assistant Secretary of BIOCOR ANIMAL HEALTH INC., a Delaware corporation (the "Corporation") does hereby certify the following:

- FIRST: The name of the Corporation is BIOCOR ANIMAL HEALTH INC.
- SECOND: The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on May 7, 1998.
- THIRD: That the Certificate of Incorporation of the Corporation is hereby amended to effect a change in FIRST Article thereof, relating to the name of the Corporation, accordingly the FIRST Article of the Certificate of Incorporation shall be amended to read in its entirety as follows:  
  
"FIRST: NAME The name of the corporation is Zoetis B Inc. (the "Corporation")."
- FOURTH: The amendment to the Certificate of Incorporation of the Corporation effected hereby was approved by the Board of Directors of the Corporation, and by written consent of the sole stockholder of the Corporation.
- FIFTH: The effective date of the amendment herein certified shall be upon filing.
