**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
SRI/SURGICAL EXPRESS, INC.

Pursuant to the provisions of Section 607.1003, Florida Statutes, the undersigned corporation, **SRI/SURGICAL EXPRESS, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

ARTICLE 1. ^{EFFECTIVE DATE}
Name of the Corporation 1-1-13

The name of the Corporation is SRI/SURGICAL EXPRESS, INC.. and its Florida document number is P94000044996.

ARTICLE 2.
Text of the Amendment

The first amendment (the "First Amendment") is to change the name of SRI/SURGICAL EXPRESS, INC. The first sentence of Article 1 of the Articles of Incorporation is amended to read as follows:

"Article 1

The name of the Corporation is: **SYNERGY HEALTH NORTH AMERICA, INC.**
