Release of Security Interest in Trademarks

This Release of Security Interest in Trademarks (this "*Release*"), effective as of February 27, 2013, is made by Wilmington Trust, National Association, successor by merger to Wilmington Trust FSB, ("*Secured Party*") in favor of Inter-Tel (Delaware), Inc. ("*Inter-Tel*"), Mitel Networks Corporation ("*Mitel*"), and all former and current subsidiary entities thereof including, but not limited to, Mitel (Delaware) Inc., formerly known as Inter-Tel (Delaware), Incorporated, formerly known as Inter-Tel, Incorporated, Inter-Tel Information Systems, Inc., Inter-Tel Integrated Systems, Inc., Inter-Tel Business Information Systems, Inc., Executone Information Business Systems, Inc., Swan Solutions, Inc., and Mitel Networks, Inc. (collectively, "*Grantees*").

WHEREAS, pursuant to the terms and conditions of that certain Agency Assignment and Amendment Agreement dated August 1, 2009 between Morgan Stanley & Co. Incorporated ("*Morgan Stanley*") and Secured Party, Morgan Stanley assigned to Secured Party its rights under that certain Trademark Security Agreements dated August 16, 2007, by which Grantees granted to Morgan Stanley a security interest in and to Grantees' right, title and interest in, to and under certain trademarks, including those set forth on Exhibits A and B attached hereto (collectively, "*Trademarks*");

WHEREAS, Inter-Tel, Mitel and Secured Party have agreed that the security interest in and to the Trademarks shall be terminated.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby terminates, cancels and releases any and all security interests it has against the Trademarks and the goodwill symbolized thereby.
