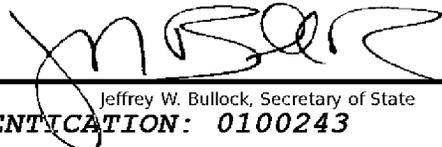

1. The name of the corporation is The Fitzpatrick Company, a Delaware corporation (the "Corporation").
2. The Certificate of Incorporation of the Corporation was filed by the Department of State of the State of Delaware on October 27, 2004.
3. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation from The Fitzpatrick Company to IDEX MPT Inc.

To effect such amendment:
