TRADEMARK AND TRADE NAME ASSIGNMENT

This Trademark and Trade Name Assignment (the "Assignment") is made as of this 3rd day of April, 2013, by and between System Planning Corporation, a Delaware corporation ("Seller"), ORBCOMM Inc., a Delaware corporation ("Parent"), and GlobalTrak Acquisition, LLC, a Delaware limited liability company ("Buyer").

WHEREAS, pursuant to a certain Asset Purchase Agreement dated March 13, 2013, as amended March 29, 2013, between Seller, on the one hand, and Parent on the other hand, Parent has agreed to acquire certain of the assets of Seller relating to the GlobalTrak Business (as defined therein) and has designated Buyer to receive title and possession of the assets purchased from Seller.

WHEREAS, Seller has adopted, used and is using the mark listed on Schedule A hereto (hereinafter, the "Mark"), which is registered in the U.S. Patent and Trademark Office as detailed in Schedule A, and owns all right, title and interest to the same, including the goodwill associated therewith; and

WHEREAS, Seller has adopted, used and is using trade names listed on Schedule B hereto (hereinafter, the "Trade Names"), and owns all right, title and interest to the same, including the goodwill associated therewith; and

WHEREAS, the Mark and the Trade Names (together with the registration associated with the Mark and the goodwill associated with the Mark and the Trade Names) are among the assets being sold to Buyer by Seller under the said Asset Purchase Agreement;;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Seller acknowledges:

1. Seller hereby assigns to Buyer all of its rights, title and interest in and to the Mark and the Trade Names, including the U.S. registration and the goodwill of the business symbolized thereby.
2. Seller further assigns to Buyer all rights to sue, bring actions and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Mark and the Trade Names.
3. Seller covenants and agrees that, upon the request of Buyer, Seller shall execute all papers, make all rightful oaths, testify on behalf of Buyer, furnish such documents, materials, information and/or assistance, and do all other lawful acts necessary to perfect the assignment of the Mark and the Trade Names to Buyer and otherwise carry out the intent of this Assignment.
4. This Assignment shall be binding upon Seller, Seller's successors and assigns, and upon all others acting by, through, with or under Seller's direction or control, and all those in privity therewith.

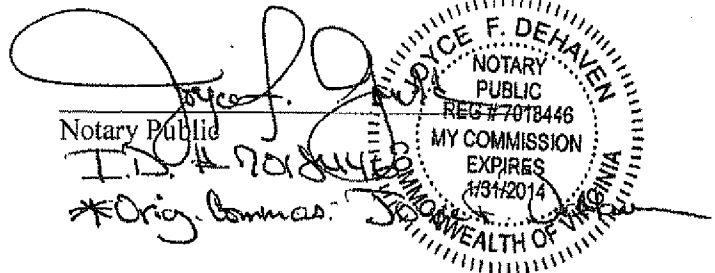

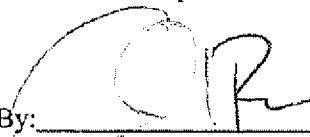

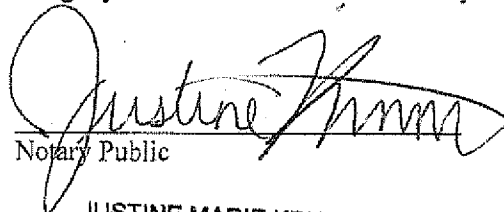
