

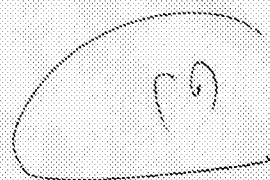
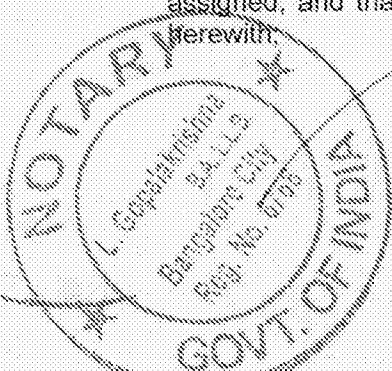

It hereby covenant that we have full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict herewith.



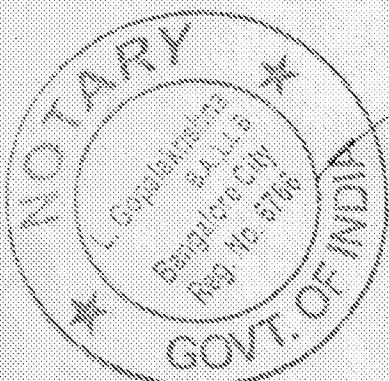
