This assignment is effective as of the January 1, 2013.



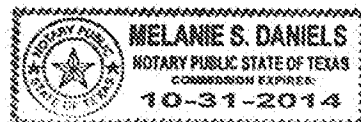
