## ASSIGNMENT OF TRADEMARK

### RECITALS:

WHEREAS, Assignor is the sole and exclusive owner of U.S. Trademark Serial No. 2,863,455 for the mark SILVACORE (the "Mark");

WHEREAS, Joining is desirous of acquiring all of Assignor's right, title and interest in and to the Mark and the applications for registration thereof, together with the goodwill of the business symbolized by the Mark, past common law causes of action, and the right to recover for past infringements of the Mark;

WHEREAS, the goods and services associated with the Mark SILVACORE, and as described in the application are as follows:

"brazing alloy," in IC 006.

WHEREAS, in order to ensure the full and effective transfer of all rights in the Mark, the goodwill associated with the Mark, and all past or future common law causes of action related to the Mark, the parties desire to execute and deliver this Assignment of Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, convey, assign, transfer and deliver to Joining, its successors and assigns, Assignor's entire right, title and interest in and to the Mark and the applications for registration thereof, together with the goodwill of the business symbolized by the Mark and past common law causes of action.

Assignor covenants and warrants that no assignment, grant, mortgage, license, or other agreement affecting the rights and property herein conveyed has been or will be made to others by Assignor (except with respect to Assignor's grant of a security interest which includes an exemption for the transaction described in this Assignment of Trademark) and that the full right to convey the same as herein expressed is otherwise possessed by Assignor.

The Commissioner of Patents and Trademarks is requested to make the proper notation of such assignment on the trademark records of the United States of America, as maintained at the United States Patent & Trademark Office.
