TERMINATION OF INTELLECTUAL PROPERTY LICENCE

Dear Sirs

FACILITY AGREEMENT DATED 11 NOVEMBER 2009 (AS AMENDED AND RESTATED FROM TIME TO TIME) BETWEEN, AMONGST OTHERS, GE CAPITAL BANK LIMITED, JAGUAR LAND ROVER LIMITED, LAND ROVER, JAGUAR LAND ROVER EXPORTS LIMITED AND JAGUAR LAND ROVER NORTH AMERICA, LLC (THE "FACILITY AGREEMENT")

INTELLECTUAL PROPERTY LICENSE DATED 11 NOVEMBER 2009 (AS AMENDED AND RESTATED FROM TIME TO TIME) BETWEEN, AMONGST OTHERS, JAGUAR LAND ROVER LIMITED, LAND ROVER, JAGUAR LAND ROVER NORTH AMERICA, LLC, LAND ROVER EXPORTS LIMITED, JAGUAR LAND ROVER EXPORTS LIMITED AND GE CAPITAL BANK LIMITED (THE "IP LICENCE")

We refer to the Facility Agreement and the IP License. We write this letter to you acting in our capacity as Agent and Security Trustee under the Facility Agreement.

Unless otherwise defined in this letter, capitalised terms used in this letter shall have the same meanings given to them in the IP Licence.

We confirm that:


- (a) the Termination Date occurred on 27 March 2013, being the date on which all amounts owed by the Obligors under the Finance Document were irrevocably and finally paid in full;
- (b) pursuant to clause 2.3 of the IP Licence, the IP Licence automatically terminated on the Termination Date; and
- (c) all records of the IP Licence at any trade mark or official registry may be removed or cancelled with respect to all trade mark registrations listed in Appendix 1 to this letter, and we shall (at the Obligors' cost) provide all reasonable assistance (including without limitation, signing any documentation necessary) in connection with any such removal or cancellation.

We note that since the IP Licence was signed, our name has changed from GE Commercial Distribution Finance Limited to GE Capital Bank Limited, that Jaguar Cars Limited's name has changed to Jaguar Land Rover Limited and Jaguar Cars Exports Limited's name has changed to Jaguar Land Rover Exports Limited.

This letter may be executed in any number of counterparts and all those counterparts taken together shall be deemed to constitute one and the same letter.


