## **RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Release"), effective as of this 11th day of April, 2013, given by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, with an address at 201 Merritt 7, Norwalk, Connecticut, 06851, as Administrative Agent ("Agent") to: (i) LT LLC, a Delaware limited liability company, (ii) Light Tower Fiber LLC, a Delaware limited liability company, (iii) Verosity Technology Partners, LLC, a Massachusetts limited liability company and (iv) Lexent Inc., a Delaware corporation (each, a "Grantor", and collectively, the "Grantors"), as follows:

### **W I T N E S S E T H**

WHEREAS, pursuant to that certain Credit Agreement dated as of November 30, 2010 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to make extensions of credit to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantors executed that certain Guaranty and Security Agreement, dated as of November 30, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") and granted to the Agent a continuing priority security interest in and to all Grantor's right, title and interest in all United States trademarks, trademark registrations and trademark applications and any renewals thereof, including as set forth on Schedule A attached hereto (collectively, the "Trademarks") to secure the Secured Obligations;

WHEREAS, in furtherance of the Security Agreement, the Grantors executed a Trademark Security Agreement, dated November 30, 2010 (the "Trademark Security Agreement"), which was duly recorded on December 8, 2010, at Reel 4428 / Frame 0118 in the United States Patent and Trademark Office;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantors and to dissolve those Liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby grants, assigns and conveys, without recourse or warranty, to the Grantors all of its rights, title and interest in the Trademarks, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantors any and all security interests or liens it has against the Trademarks.
