ASSIGNMENT

WHEREAS, Gränges AB (formerly known as Sapa AB) ("Gränges") and Sapa AB (formerly known as New Sapa AB) ("Sapa") have entered into (i) a demerger plan, dated 19 December 2012 (the "Demerger Plan), pursuant to which some of the assets and liabilities of Gränges have been transferred to Sapa through a partial demerger in accordance with Chapter 24, Section 1, item 2 in the Swedish Companies Act and (ii) a master separation agreement (the "Master Separation Agreement"), supplementing the Demerger Plan. Pursuant to section 4 of the Demerger Plan Gränges has transferred the trademarks set out below to Sapa. This notarial deed confirms the said transfer and is subject to all terms and conditions of the Demerger Plan and the Master Separation Agreement.


