AGREEMENT TO ASSIGN TRADEMARKS

WHEREAS, the trademark law of the United States does not permit the assignment of the Applications from FML to CAI until certain conditions are met, but once the conditions are met FML will assign the Section 44 application to CAI or take such other actions as necessary for CAI to be the owner of all applications for registration in the United States of ALIEN DAWN as they relate to the children's series and related merchandise.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which hereby are acknowledged, the parties agree as follows:

- Promptly after the FML European Community Trademark application on which the Section 44 Application was based is registered, FML will file with the USPTO the Community Trademark registration and as soon as the law permits will assign to CAI the Section 44 Application and will record the assignment with the USPTO The assignment shall be in the form attached as Schedule A hereto
- 2. Following notification by the USPTO of the acceptance of the assignment of the Section 44 application, FML will file a withdrawal of the ITU application with the USPTO.
- In the event that for any reason the USPTO does not permit the assignment of the Section 44 application from FML to CAI, then, (a) if by that time use has been made of the ALIEN DAWN trademark under International Class 41, FML will file a Statement of Use with the USPTO and once it is accepted will assign the ITU application to CAI, and also shall file a new application for registration of ALIEN DAWN on behalf of and in the name of CAI in such other International Classes as to which the parties agree, or (b) if by that time use has not been made of the ALIEN DAWN trademark under International Class 41, FML shall file a new application for registration of ALIEN DAWN on behalf of and in the name of CAI in International Class 41 and such other International Classes as to which the parties agree
- 4. CAI agrees both to execute such instruments and other documents as are necessary for FML to fully perform its obligations set forth in this Agreement, and to promptly and fully cooperate with FML as requested by FML for it to fully perform its obligations set forth in this Agreement.


