## TRADEMARK ASSIGNMENT

Assignor warrants the Marks have not been otherwise previously pledged, assigned or encumbered by the undersigned. Assignor agrees to cooperate with Assignee and to execute and deliver all papers, instruments and assignments as may be reasonably necessary to vest all right, title and interest in and to

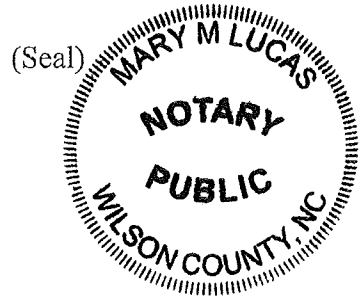
the aforementioned Marks, including, without limitation, recordation of the assignments with the United States Patent and Trademark Office.
