(Pursuant to 8 Del. C. § 253)**

VISHAY TRANSDUCERS LTD., a Delaware corporation (the "Corporation"), does hereby certify as follows:

FIRST: That this Corporation is incorporated pursuant to the General Corporation Law of the State of Delaware (the "DGCL").

SECOND: That this Corporation owns all of the outstanding shares of each class of the stock of Vishay BLH, Inc., a Delaware corporation (the "Subsidiary").

THIRD: That on December 3, 2010, the Board of Directors of the Corporation duly adopted the following resolutions authorizing the merger of the Subsidiary with and into the Corporation (the "Merger"):

RESOLVED, that the Corporation merge the Subsidiary with and into the Corporation in accordance with Section 253 of the DGCL, and that all of the estate, property, rights, privileges, powers and franchises of the Subsidiary be vested in and held and enjoyed by the Corporation as fully and entirely and without change or diminution as the same were before held and enjoyed by the Subsidiary in its name; and be it further

RESOLVED, that the Corporation shall assume all of the Subsidiary's liabilities and obligations; and be it further

RESOLVED, that the Corporation shall cause to be executed, filed, and recorded the documents prescribed by the laws of the State of Delaware and will cause to be performed all necessary acts within the State of Delaware; and be it further

RESOLVED, that the Merger herein provided for shall become effective at 12:01 a.m. on December 19, 2010; and be it further

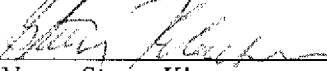
RESOLVED, that the President, any Vice President, the Secretary and the Treasurer of the Corporation (the "Proper Officers") be, and each of them hereby is, authorized to certify a Certificate of Ownership and Merger setting forth a copy of the foregoing resolutions, and to cause the same to be filed with the Delaware Secretary of State and to do all acts and things, whatsoever, which may be in any way necessary or appropriate to effect said Merger; and be it further

RESOLVED, that the Proper Officers of the Corporation are hereby authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or proper to effect said Merger.

FOURTH: Anything herein or elsewhere to the contrary notwithstanding, this Certificate of Ownership and Merger may be amended or terminated and abandoned by the Board of Directors of the Corporation at any time prior to the date of filing of this Certificate with the Delaware Secretary of State.
