**PATENT AND TRADEMARK ASSIGNMENT AND TERMINATION OF PATENT AND  
TRADEMARK SECURITY INTEREST**

WHEREAS, (a) mFormation Software Technologies, Inc. (the "**Secured Party**"), as an indirect assignee from Clearlake Capital Partners II (Master), L.P. ("**Clearlake**") (as assignee from WF Fund IV Limited Partnership, c/o/b as Wellington Financial LP and Wellington Financial Fund IV (f/k/a WF Fund III Limited Partnership) ("**Wellington**") (as assignee from Silicon Valley Bank "**SVB**")), is party to that certain Loan and Security Agreement (Working Capital Line of Credit), dated as of April 23, 2008, between the Secured Party, as lender, and mFormation Technologies, Incorporated (the "**Borrower**"), as borrower (the "**Senior Loan Agreement**" and, collectively with certain related documents evidencing the loans made pursuant thereto and security interests granted to secure such loans, as each of the foregoing may be or may have been amended, restated, supplemented or otherwise modified from time to time, the "**Senior Loan Documents**"), and (b) the Secured Party, as an indirect assignee from Clearlake (as assignee from Wellington), is party to a certain Loan and Security Agreement dated as of March 25, 2011, between the Secured Party, as lender, and the Borrower, as borrower (the "**Term Loan Agreement**" and, collectively with certain related documents evidencing the loans made pursuant thereto and security interests granted to secure such loans, as each of the foregoing may be or may have been amended, restated, supplemented or otherwise modified from time to time, the "**Term Loan Documents**" and, together with the Senior Loan Documents, the "**Loan Documents**");

WHEREAS, as security for the Borrower's obligations under the Senior Loan Agreement and the Term Loan Agreement, the Borrower granted the Secured Party a continuing security interest in and lien on all or substantially all of the Borrower's assets including, without limitation, all of the Borrower's personal and intangible property (collectively, the "**Collateral**");

WHEREAS, (i) a true and correct copy of that certain Intellectual Property Security Agreement dated as of March 7, 2011 by and between the Borrower and SVB, was recorded by the U.S. Patent and Trademark Office on March 8, 2011 at Reel Number 025916/Frame Number 0354 ("**SVB Patents**") and on March 8, 2011 at Reel 4492, Frame 0357 ("**SVB Trademarks**"); and (ii) a true and correct copy of the Term Loan Agreement was recorded by the U.S. Patent and Trademark Office on July 27, 2012 at Reel Number 028655/Frame Number 0306 ("**Wellington Patents**");

WHEREAS, the Borrower defaulted in its obligations owed to the Secured Party under the Loan Documents;

WHEREAS, as a result of such default, pursuant to Section 9-610 *et seq.* of the UCC, the Secured Party foreclosed upon and received transfer of certain of the Collateral, including the SVB Patents, the SVB Trademarks, and the Wellington Patents, and the Borrower transferred such assets to the Secured Party on or about September 21, 2012.

NOW, THEREFORE, for good and valuable consideration, receipt of which are hereby acknowledged, the parties hereto agree as follows:

1. On or about September 21, 2012, the Borrower did hereby cause to be conveyed unto the Secured Party, all right, title and interest of the Borrower in and to the assets identified on **Exhibit A** hereto and **Exhibit B** hereto (collectively, the “*Transferred Assets*”);


2. The Secured Party confirms that it is now the record owner of the Transferred Assets and that all of its security interests in and liens on the Transferred Assets have been extinguished. The Secured Party authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the same.
