AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
of
MCKEE WALLWORK & COMPANY, LLC
(NM SCC No. 1868876)

The undersigned, being the managing member of McKee Wallwork & Company, LLC, formerly known as McKee Wallwork Cleveland, LLC, formerly known as McKee Wallwork Henderson, LLC, formerly known as McKee Wallwork, LLC, hereby files the following Amended and Restated Articles of Organization, which shall supersede the original Articles of Organization and all prior amendments:

ARTICLE I [AMENDED]

Name

The name of the limited liability company is **McKee Wallwork & Company, LLC**.

ARTICLE II [AMENDED]

Duration

The duration of the existence of the limited liability company shall not exceed fifty (50) years after the filing of the original Articles of Organization with the New Mexico Public Regulation Commission.

ARTICLE III [AMENDED]

Registered Agent and Office

The limited liability company's registered office and current principal place of business in the State of New Mexico is located at 1030 18th Street NW, Albuquerque, New Mexico 87104. Its registered agent at that address for service of process is Stephen McKee.

ARTICLE IV

Management

Management of the business and affairs of the limited liability company shall be vested in the members subject to provisions in the Operating Agreement which may vest particular management responsibilities in a certain member or group or class of members.

ARTICLE V

Right to Amend

The limited liability company reserves the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by the New Mexico Limited Liability Company Act.


ARTICLE VI
