TRADEMARKS

This Termination of Security Interest in Trademarks (this "Termination") is executed as of April 9, 2013, by Silicon Valley Bank (the "Secured Party"), in connection with that certain Intellectual Property Security Agreement dated as of June 29, 2012 (as the same may have been amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), by and among the Secured Party, Gilt City, Inc., a Delaware corporation ("City"), Gilt Groupe, Inc., A Delaware corporation ("Groupe"), Gilt Travel, Inc., a Delaware corporation ("Travel"), Gilt Global Trading & Procurement Company (f/k/a Gilt Global Trading & Procurement Company Limited), a company incorporated under the laws of Ireland ("GGTP") and Gilt City (f/k/a Gilt City Limited), a company incorporated under the laws of Ireland ("GC"), and together with City, Groupe, Travel and GGTP, the "Grantors").

WHEREAS, pursuant to the terms of the IP Security Agreement, Travel granted to the Secured Party a security interest in all of its right, title and interest in, to and under its intellectual property ("Intellectual Property Collateral"), including without limitation, the trademarks identified on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, Secured Party has agreed to terminate and release its security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates and releases its security interest in the Intellectual Property Collateral effective as of the date set forth above.

NOTWITHSTANDING ANYTHING TO THE CONTRARY, THIS TERMINATION IS NOT INTENDED TO RELEASE THE SECURITY GRANT OF THE GRANTORS (OTHER THAN TRAVEL) ISSUED TO THE SECURED PARTY PURSUANT TO THE IP SECURITY AGREEMENT.

This document may be filed along with any other necessary documentation with the United States Patent and Trademark Office, to evidence the termination and release granted herein. The Secured Party hereby agrees, at the sole costs and expense of Gilt Travel, to deliver any further releases or termination statements that may be reasonably necessary to effect the termination and release contemplated hereby.
