**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of April 12, 2013, is made by General Electric Capital Corporation, as administrative agent ("Agent"), under that certain Credit Agreement (the "Credit Agreement") (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with the Credit Agreement dated as of September 30, 2010 (as amended, restated, supplemented or otherwise modified from time to time), and together with all general security agreements and trademark security agreements entered into in connection therewith or in connection with prior versions thereof, among Borrowers, Holdings and the other Credit Parties (each a "Grantor" and, collectively, the "Grantors"), the Agent and the Lenders signatory thereto from time to time (each individually a "Lender" and collectively, the "Lenders"), the Lenders made credit extensions to the Credit Parties;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain Trademark Security Agreements, Patent Security Agreements and Copyright Security Agreements described on Annex I attached hereto (collectively, the "Security Agreements"), the Grantors granted to Agent a security interest in certain trademarks and patents owned by them, including those listed on Annex I attached hereto (the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") and The Copyright Office (the "Copyright Office") on the dates and on the reels and frames and document and volume as set forth on Annex I hereto.

NOW THEREFORE, Agent, on behalf of itself and as agent to each other Lender, hereby unconditionally, irrevocable and absolutely terminates, releases and forever discharges hereby without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and Agent hereby retransfers and reassigns any and all such right, title and interest (if any) that Agent may have in the Intellectual Property Collateral to the Grantor.


Agent agrees, at the Grantors' expense, to provide them with the information and additional authorization reasonably required or desirable to effect the release and record of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
