**RELEASE AND REASSIGNMENT OF SECURITY INTEREST IN

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby releases, retransfers and reassigns to Pledgor, without representation or warranty, all of Agent's right, title and interest in and to its security interest in the Released Marks ONLY and the goodwill associated therewith.

Nothing contained in this Release and Reassignment of Security Interest in Trademarks and Trademarks Applications shall be construed as a release, retransfer or reassignment of any security interest which Agent may have in the Marks which have not been specifically identified on Exhibit A attached hereto or any other collateral described in the Agreement or otherwise.
