

APTEAN HOLDINGS, INC., a corporation organized and existing under the laws of the State of Delaware, does hereby certify the following as the surviving corporation in a merger between two Delaware corporations:

1. The names and states of incorporation of the merging corporations are as follows:
 - a. Aptean Holdings, Inc., a Delaware corporation ("Aptean Holdings"); and
 - b. CDC Software, Inc., a Delaware corporation ("CDC").
2. A merger has been approved, adopted, certified, executed and acknowledged by the Board of Directors and sole stockholders of Aptean Holdings and CDC in accordance with the laws of Delaware and according to the terms of a certain Agreement and Plan of Merger.
3. Aptean Holdings, pursuant to Section 251 of the Delaware General Corporation Law, does hereby merge CDC with and into itself, with Aptean Holdings being the surviving corporation (the "Merger"). As a result, the name of the surviving corporation in the Merger is "Aptean Holdings, Inc."
4. The Certificate of Incorporation of Aptean Holdings shall be the Certificate of Incorporation of the surviving corporation.
5. The executed Agreement and Plan of Merger is on file at the office of Aptean Holdings at 1155 Perimeter Center West, Suite 700, Atlanta, Georgia 30338.
6. A copy of the executed Agreement and Plan of Merger will be furnished by Aptean Holdings, on request and without cost, to any stockholder of either of the merging corporations.
7. The Merger shall be effective upon the filing of this Certificate of Merger with the Secretary of State of Delaware, but shall be contingent upon and immediately follow the separate merger of Yaletown US Holdings, Inc. into Aptean Superior Holdings, Inc.
