## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 15, 2013 (this "Release"), is made by **JPMORGAN CHASE BANK, N.A.** (the "Assignor"), in its capacity as administrative agent under that certain Credit Agreement dated as of December 31, 2012 (as amended, amended and restated, extended, supplemented or otherwise modified from time to time, the "Credit Agreement"), in favor of **TRIBUNE MEDIA SERVICES, LLC**, a Delaware limited liability company (the "Assignee"). Capitalized terms used but not defined herein shall have the meanings set forth in the Credit Agreement.

### W I T N E S S E T H:

**WHEREAS**, the Assignor and the Assignee are parties to (i) that certain Guarantee and Security Agreement, dated as of December 31, 2012 (the "Security Agreement") and (ii) that certain Trademark Security Agreement, dated as of December 31, 2012 (the "Trademark Security Agreement");

**WHEREAS**, pursuant to the Trademark Security Agreement, the Assignee pledged and granted to the Assignor a continuing security interest in and Lien on the Assignee's right, title and interest in and to the items set forth on Schedule 1 hereto (collectively, the "Trademark Collateral");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 31, 2012, on Reel 4932, Frame 0821;


**WHEREAS**, the Assignee desires that the Assignor terminate and release its continuing security interest in and Lien on the Assignee's right, title and interest in and to the Trademark Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its continuing security interest in and Lien on the Assignee's right, title and interest in and to the Trademark Collateral set forth on Schedule 1, and reassigns and transfers to the Assignee all right, title and interest that the Assignor may have in the Trademark Collateral. The Assignor hereby authorizes the Assignee, or the Assignee's authorized representative, to record this Release with the United States Patent and Trademark Office.
