Gen-Probe Transplant Diagnostics, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), hereby certifies:

FIRST: The name of the Corporation is Gen-Probe Transplant Diagnostics, Inc.

SECOND: The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on October 2, 2003. The Certificate of Incorporation of the Corporation was renewed on June 16, 2008 and amended on May 1, 2009.

THIRD: The Board of Directors of the Corporation, acting in accordance with the provisions of Section 141 and 242 of the General Corporation Law of the State of Delaware, adopted resolutions amending its Certificate of Incorporation as follows:
