**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This TERMINATION AND RELEASE dated as of April 5, 2013, is made by and among Wells Fargo Bank, National Association, successor to Fidelity Bank, National Association and to First Fidelity Bank, National Association ("Secured Party") and Cedar Investments, Inc., a Delaware corporation with its principal place of business located at 900 Market Street, Wilmington, Delaware 19801 ("Assignor"), and Bonney Forge Corporation, a Delaware corporation with its principal place of business located at P.O. Box 359, Cedar and Meadow Streets, Allentown, Pennsylvania 18105 ("Borrower").

WITNESSETH:

WHEREAS, pursuant to that certain Assignment for Security (Trademarks) dated as of March 22, 1988, by and between Fidelity Bank, National Association and Borrower, executed as a condition of that certain Loan and Security Agreement between the parties, Borrower granted to Fidelity Bank, National Association a security interest in, and mortgage on, all right, title and interest of Borrower in and to the Collateral, as defined therein ("First Collateral"), including without limitation, to the trademarks listed on attached Schedule A, to secure the payment, performance and observance of the Obligations (as defined in the Loan and Security Agreement), said Assignment for Security (Trademarks) having been recorded with the U.S. Patent and Trademark Office on March 31, 1988, starting at reel/frame 0597/0336;

WHEREAS, pursuant to that certain Memorandum of Security Agreement (Trademarks) dated as of December 22, 1994, by Assignor, executed as a condition of that certain Revolving Credit, Term Loan and Commercial Loan Agreement dated as of December 22, 1994, between Borrower and First Fidelity Bank, National Association, Assignor granted to First Fidelity Bank, National Association a security interest in, and mortgage on, all right, title and interest of Assignor in and to the Collateral, as defined therein ("Second Collateral"), including without limitation, to the trademarks listed on attached Schedule B, to secure the payment, performance and observance of the Liabilities (as defined in the Revolving Credit, Term Loan and Commercial Loan Agreement), said Memorandum of Security Agreement (Trademarks) having been recorded with the U.S. Patent and Trademark Office on January 17, 1995, starting at reel/frame 1277/0160; and

WHEREAS, Secured Party desires to release and discharge the security interests in the First Collateral and the Second Collateral, including but not limited to those trademarks identified in Schedules A and B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and intending to be legally bound hereby, Secured Party hereby states as follows:

1. Definitions: All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the aforementioned agreements.

2. Release of Security Interest in First Collateral: The Secured Party hereby releases and remits to Borrower any and all right, title and interest in and to the First Collateral, including but not limited to those trademarks identified in Schedule A attached hereto.


3. Release of Security Interest in Second Collateral: The Secured Party hereby releases and remits to Assignor any and all right, title and interest in and to the Second Collateral, including but not limited to those trademarks identified in Schedule B attached hereto.

4. Further Assurances: The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.
