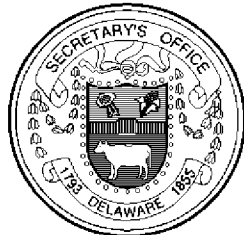

**CERTIFICATE OF AMENDMENT NO. 2 TO
AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
GREENOLOGY, INC.**

(Pursuant to Section 242 of the
General Corporation Law of the State of Delaware)

Greenology, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "**General Corporation Law**"),

DOES HEREBY CERTIFY:

1. That the name of this corporation is Greenology, Inc., and that this corporation was originally incorporated pursuant to the General Corporation Law on September 2, 2009 under the name Greenology, Inc. An Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on December 17, 2009 and a Certificate of Amendment No. 1 to Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on March 30, 2010 (the "**Existing Certificate of Incorporation**").

2. This Certificate of Amendment No. 2 to Amended and Restated Certificate of Incorporation amends the provisions of the Existing Certificate of Incorporation. Pursuant to Sections 242 of the General Corporation Law, and as duly adopted and approved by written consent of the stockholders of the Corporation in accordance with Section 228 of the General Corporation Law the Corporation hereby amends the Existing Certificate of Incorporation as follows:

3. Article FIRST of the Existing Certificate of Incorporation is hereby amended by deleting it in its entirety and replacing it with the following:

"The name of this corporation is JouleX, Inc. (the "**Corporation**")."

4. The foregoing Amendment No. 2 to Amended and Restated Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Sections 141, 228 and 242 of the General Corporation Law of the State of Delaware.
