RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of ____April 16__, 2013 ("Effective Date") by Wells Fargo Bank Northwest, N.A., a National Banking Association, in its capacity as Collateral Trustee, with its principal office at MAC U1240-026, 260 N. Charles Lindbergh Drive, Salt Lake City, Utah 84116, Attn: Corporate Trust Services ("Secured Party"), in favor of Ameraft Building Products Co., Inc. ("Debtor"). All terms used in this Release with initial capital letters and not defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (as defined below).

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on July 2, 2007, at Reel 003572, Frame 0386;

WHEREAS, Debtor has paid all of its outstanding indebtedness to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests Secured Party has against the Trademark Collateral. Secured Party represents and warrants that it has the full power and authority to execute this Release and that it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral.
