**RELEASE OF TRADEMARK SECURITY INTEREST**

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of April 19, 2013, is made by General Electric Capital Corporation, as administrative agent ("Grantee"), in favor of Aquilex LLC, a Delaware limited liability company, Aquilex Intermediate Holdings LLC, a Delaware limited liability company, AquilexHydrochem LLC, a Delaware limited liability company, AquilexHydrochem Industrial Cleaning LLC, a Delaware limited liability company, and Aquilex Finance LLC, a Delaware limited liability company (collectively, the "Existing Grantors").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of February 3, 2012 and recorded with the United States Patent and Trademark Office on February 3, 2012 at Reel 4710 Frame 0697 (the "Trademark Security Agreement"), made by AquilexSMS LLC, a Florida limited liability company, AquilexWSI LLC, a Delaware limited liability company, Aquilex Specialty Repair and Overhaul LLC, a Delaware limited liability company (collectively, the "Previously Released Grantors") and the Existing Grantors (together with the Previously Released Grantors, the "Grantors") in favor of Grantee, each Grantor granted to Grantee a lien on and security interest in all of such Grantor's right, title and interest in, to and under all of its Trademark Collateral (as defined in the Trademark Security Agreement; hereinafter, the "Trademark Collateral"), including the Trademark Collateral listed on Schedule A hereto;


**WHEREAS**, pursuant to that certain Partial Release of Trademark Security Interest, dated as of March 29, 2013 and recorded with the United States Patent and Trademark Office on April 1, 2013 at Reel 4995 Frame 0480, by Grantee in favor of the Previously Released Grantors, Grantee released any and all liens on and security interests in the Previously Released Grantors' Trademark Collateral granted pursuant to the Trademark Security Agreement; and

**WHEREAS**, pursuant to the terms of that certain payoff letter, dated as of the date hereof, by and among, among others, Grantee and the Existing Grantors, Grantee has consented to the release of the lien on and security interest in the Existing Grantors' Trademark Collateral granted pursuant to the Trademark Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Existing Grantors' right, title and interest in, to and under the Trademark Collateral granted pursuant to the Trademark Security Agreement, including the Trademark Collateral listed on Schedule A hereto, together with (a) all renewals and extensions of the foregoing, (b) all goodwill of the business connected with the use of, and symbolized by, any of the foregoing and (c) all income, royalties, proceeds and Liabilities (as defined in the Trademark Security Agreement) at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
