AFTER-ACQUIRED TRADEMARK PLEDGE AND SECURITY AGREEMENT
(FIRST SUPPLEMENTAL FILING)

This AFTER-ACQUIRED TRADEMARK PLEDGE AND SECURITY AGREEMENT (FIRST SUPPLEMENTAL FILING), dated as of April 22, 2013, is made by and among the signatories hereto (each a "Grantor," and collectively, the "Grantors"), and Wells Fargo Bank, National Association, as collateral agent (in such capacity as collateral agent, the "Collateral Agent") for the Secured Parties (as defined in the Security Agreement referred to below).

WHEREAS, reference is made to that certain Amended and Restated Credit and Guaranty Agreement, dated as of August 16, 2011 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among Vicar Operating, Inc., a Delaware corporation ("Company"), VCA Antech, Inc., a Delaware corporation, certain Subsidiaries of Company, as Guarantors, the Lenders party thereto from time to time, Wells Fargo Bank, National Association, as Administrative Agent, Collateral Agent, Issuing Bank and Swing Line Lender, and Bank of America, N.A. and JPMorgan Chase Bank, N.A., as Co-Syndication Agents, and the other agents party thereto. Capitalized terms used and not defined herein have the meanings given such terms in the Credit Agreement.

WHEREAS, in connection with the Credit Agreement, the Grantors executed and delivered that certain Pledge and Security Agreement, dated as of August 19, 2010, by and among the Grantors, certain other grantors thereunder and the Collateral Agent (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Security Agreement").

WHEREAS, pursuant to the terms of the Credit Agreement and the Security Agreement, the Grantors executed and delivered that certain Trademark Pledge and Security Agreement, dated as of September 1, 2011 (the "Trademark Pledge and Security Agreement"), to grant to the Collateral Agent for its benefit and the benefit of the Secured Parties a continuing security interest in all of the Trademark Collateral (as defined in the Trademark Pledge and Security Agreement) to secure all of its Obligations.

WHEREAS, the Grantors have acquired additional trademarks registered with the U.S. Patent and Trademark Office, as indicated on Exhibit A attached hereto (the "Additional Marks"), and the Secured Parties and the Grantors desire to amend Schedule 1 of the Trademark Pledge and Security Agreement to include the Additional Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby agree as follows:

1. Schedule 1. Schedule 1 shall be amended to include the Additional Marks. The security interest granted to the Secured Parties under the Trademark Pledge and Security Agreement shall extend to the Additional Marks, and the Additional Marks shall be, and be deemed to be, part of the Trademark Collateral.
