NUNC PRO TUNC ASSIGNMENT

WHEREAS, Kurt Salmon US Inc., a Delaware corporation having a place of business at Suite 900, 1355 Peachtree Street NE, Atlanta, Georgia 30309 (hereinafter referred to as "Kurt Salmon" or "Assignor") adopted, used, and until on or about January 13, 2012, owned the trademark GOALPOST which was registered in the United States Patent and Trademark Office, Reg. No. 3,506,229 for "Computer software for use in measuring and calculating costs and productivity" (the "GoalPost Software") in Class 9 (the "GoalPost Trademark"); and,

WHEREAS, Kurt Salmon has registered and until on or about January 13, 2012, was using the following domain names: GETGOALPOST.BIZ; GETGOALPOST.COM; GETGOALPOST.INFO; GETGOALPOST.NET; GETGOALPOST.ORG; GOALPOST.BIZ; GOALPOSTHOME.COM; GOALPOSTWEB.COM; KSAGOALPOST.COM; and MYGOALPOST.COM for the promotion of its GoalPost Software (collectively, the "GoalPost Domains"), and,

WHEREAS, until on or about January 13, 2012, Kurt Salmon owned all right title and interest in the design, look and feel, code and content of the websites associated with the GoalPost Domains (the "GoalPost Copyrights"); provided however, that the GoalPost Copyrights exclude those websites used by Assignor that only contain links to the GoalPost Domains; and,

WHEREAS, on or about January 13, 2012, Kurt Salmon, for good and valuable consideration, assigned, sold and transferred unto Knighted LMS, Inc. a New York corporation having a principal place of business at 145 N. Highland Ave., Ossining, New York 10562 (hereinafter "Knighted LMS" or "Assignee") the entire right, title and interest in and to the GoalPost Software, the GoalPost Trademark, the GoalPost Domains, and the GoalPost Copyrights, together with all of the good will of the business relating thereto; and,

WHEREAS, the said aforementioned assignment and transfer of the GoalPost Trademark that occurred on or about January 13, 2012 was not recorded in the U.S. Patent and Trademark Office and it is now desired to complete the recorded title in and to the GoalPost Trademark, the registration thereof, and the good will of the business relating thereto; and,

WHEREAS, the said aforementioned assignment and transfer of the GoalPost Domains and the GoalPost Copyrights that occurred on or about January 13, 2012 was not recorded with the appropriate domain name registration authority, Internet service provider and/or governmental entities;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be bound thereby, agree to the following terms and conditions:

1. Assignment of GoalPost Trademark.

Kurt Salmon does hereby acknowledge that as of January 13, 2012, it sold, assigned and transferred unto Knighted LMS, its assigns and legal representatives, the entire right, title and

interest in and to the said GoalPost Trademark, the registration thereof, and the good will of the business associated therewith, together with the right to sue and collect damages for any past infringement thereof.

2. Assignment of GoalPost Domains and GoalPost Copyrights.

Kurt Salmon does hereby acknowledge that as of January 13, 2012, it sold, assigned and transferred unto Knighted LMS, its assigns and legal representatives, the entire right, title and interest in and to the said GoalPost Domains and GoalPost Copyrights.

3. Transfer of GoalPost Domains.

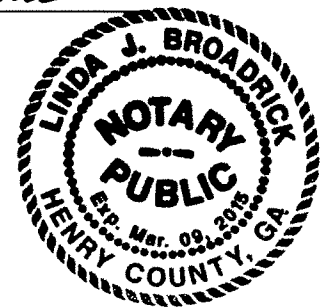
Kurt Salmon further covenants and agrees that it will execute, acknowledge and deliver such additional instruments of assignment and take all other actions as needed in order to fulfill the transition of ownership of the GoalPost Domains to Knighted LMS or its designated agent for domain name management, namely Knighted IP, LLC. Such actions may include the transmission of necessary documentation and/or the correspondence with the appropriate domain name registration authority, Internet service provider and/or governmental entities to authorize transfer of the GoalPost Domains.
