**ASSIGNMENT, BILL OF SALE

This Instrument is in all respects subject to the provisions of the Transaction Documents and is not intended in any way to supersede, limit, qualify or expand any provision of such Transaction Documents.

It is understood that the Assignor, contemporaneously with the execution and delivery of this Instrument may be further executing and delivering to the Assignees certain assignments and other instruments of transfer which cover certain of the Assets, the purpose of which is to supplement, facilitate and otherwise implement the transfer intended hereby.


At any time and from time to time hereafter, at any other party's request, each party shall take any and all steps and shall execute, acknowledge and deliver to the other party any and all future instruments and assurances necessary or reasonably requested in order to more fully carry out the purposes hereof. This Instrument shall be binding upon and inure to the benefit of the respective successors and permitted assigns of the Assignor and the Assignees.
