The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registrations to the said ASSIGNEE.

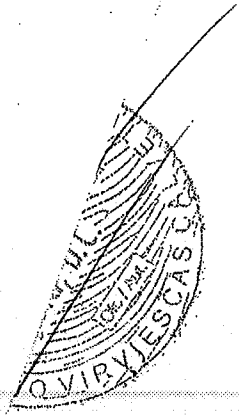
