WHEREAS Assignor and Assignee wish to take advantage of certain administrative efficiencies by consolidating their respective trademark portfolios under Assignee;


NOW THEREFORE for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto agree as follows:

Assignor hereby assigns to Assignee (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith including, without limitation, registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof; (ii) all reissues, extensions or renewals thereof; (iii) all rights of action, powers and benefit thereto, due or accrued, including the right to sue for and recover in the Assignee's own name and that of its successors, assigns and other legal representatives all remedies of every nature, including, without limitation, rights to injunctive relief, damages, profits, costs and attorney fees, arising out of past infringement of the marks or injury to the related goodwill; and, (iv) all goodwill of the business symbolized by any trademark. A list of registered trademarks, applications for trademark registration, and common law marks so assigned is attached hereto as Exhibit A.
