**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY  
COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of April 24<sup>th</sup>, 2013, is made by **PNC BANK, NATIONAL ASSOCIATION**, as Agent for the Lenders (the “**Agent**”) under the Credit Agreement and Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Revolving Credit and Security Agreement).

**WHEREAS**, in connection with that Credit Agreement and Security Agreement, dated as of August 17, 2007 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements, patent security agreements, and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the “**Credit Agreement**”), by and between **Holliston LLC** (the “**Borrower**”), the financial institutions from time to time party thereto and the Agent for the Lenders;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to the Assignment for Security Agreements, dated as of August 17, 2007, between the Borrower and the Agent as arranger and agent for the Lenders (the “**Security Agreements**”), the Borrower granted a security interest in the trademarks listed on Annex I hereto owned by the Borrower (the “**Intellectual Property Collateral**”); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the date and on the reel and frame set forth on Annex I hereto;

**WHEREAS**, in connection with the acquisition of National City Corp. by PNC Financial Services, PNC acquired National City Corp.’s secured interests under the security agreements referred to below and will be executing this Release as successor to National City Corp.;


**NOW THEREFORE**, the Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interests in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby [re]assigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Borrower.

The Agent agrees, at the Borrower’s expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization reasonably required or desirable to effect the release of the Agent’s security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
