RELEASE OF TRADEMARK SECURITY INTEREST dated as of April 2, 2013 (this "Release"), by THE BANK OF NOVA SCOTIA, as Administrative Agent (as defined below) to WEIGHT WATCHERS INTERNATIONAL, INC., a Virginia corporation ("WWI"). Capitalized terms used herein and not otherwise defined shall have the respective meanings assigned to such terms in the Credit Agreement, the Security Agreement or the Trademark Security Agreement, as applicable, referred to below.

Reference is made to (i) the Credit Agreement dated as of September 29, 1999 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among WWI, WW Funding Corp., a Delaware Corporation (together with WWI, "the Borrowers"), the Lenders as are or may become parties thereto and The Bank of Nova Scotia, N.A., as administrative agent (in such capacity, the "Administrative Agent"), (ii) the Security Agreement dated as of September 29, 1999 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among WWI, each of its U.S. subsidiaries (together with WWI, "the Grantors"), in favor of the Administrative Agent and (iii) the Trademark Security Agreement dated as of September 29, 1999 (as amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") by WWI in favor of the Administrative Agent.

WHEREAS, pursuant to the Credit Agreement, the Security Agreement and the Trademark Security Agreement, the Grantors mortgaged, pledged, hypothecated and granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in the Trademark Collateral (as defined below), and the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 14, 1999 in Reel/Frame Number 1971/0642.

WHEREAS, in connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, the Grantors have informed the Administrative Agent of their desire to obtain the release of all right, title and interest of the Administrative Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademark Collateral granted under the Credit Agreement, the Security Agreement and the Trademark Security Agreement.

NOW, THEREFORE, in exchange for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Credit Agreement, the Security Agreement and the Trademark Security Agreement, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby terminate, release, cancel, relinquish and discharge any and all security interests it has against all of the following property (the "Trademark Collateral").

- (a) all trademarks, trade names, trade dress, service marks, logos, other source of business identifiers, and designs (all of the foregoing items in this clause (a) being collectively called a "Trademark"), now existing in the United States or hereafter adopted or acquired in the United States, and all registrations and recordings thereof and all applications (with the exception of those described below) in connection therewith, including registrations, recordings and

applications in the United States Patent and Trademark Office, including those referred to in Item A of Attachment I hereto, and all renewals thereof;

- (b) all Trademark licenses and other agreements providing each Grantor with the right to use any items of the type described in clause (a), including each Trademark license referred to in Item B of Attachment I hereto;
- (c) all the goodwill of the business connected with the use of, and symbolized by the items described in, clause (a);
- (d) the right to sue third parties for past, present and future infringements of any Trademark Collateral described in clause (a) and, to the extent applicable, clause (b); and
- (e) all proceeds of, and rights associated with, the foregoing, including any claim by each Grantor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, including any Trademark, Trademark registration or Trademark license referred to in Item A and Item B of Schedule I hereto, or for any injury to the goodwill associated with the use of any such Trademark or for breach or enforcement of any Trademark license and all rights corresponding thereto throughout the world.

Notwithstanding the foregoing, the Trademark Collateral shall not include those applications filed in jurisdictions in which the assignment of a security interest in or the transfer of title of such applications is prohibited by local law or would jeopardize the Grantor's rights therein, including, with respect to applications filed in the U.S. Patent and Trademark Office, any such applications filed pursuant to 15 U.S.C. Section 1051(b), unless and until such time as Grantor files a verified Statement of Use pursuant to 15 U.S.C. Section 1051(d), at which time such applications shall be deemed to constitute "Trademark Collateral" for purposes of this Security Agreement.

Any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void and the Administrative agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Trademark Collateral to the applicable Grantor.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents, including filings with the United States Patent and Trademark Office, the Canadian Intellectual Property Office and other necessary filings, in each case as reasonably requested by the Grantors and at the expense of the Grantors, to evidence this Release. The Administrative Agent shall take all further actions and provide to the Grantors (or their assigns or other legal representatives) all such cooperation and assistance, as reasonably requested by the Grantors and at the expense of the Grantors, to more fully and effectively effectuate the purposes of this Release.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE



BINDING UPON THE ADMINISTRATIVE AGENT'S REPRESENTATIVES,  
SUCCESSORS, ASSIGNS AND TRANSFEREES.
