Timothy P. Slaughter, duly sworn on oath, states and deposes as follows:

1. I make this affidavit on personal knowledge, and I am competent to testify to the following facts.

2. I am Vice President of Finance of R & O Transportation LLC.

3. This Affidavit is filed in connection with the trademark **R & O (stylized)**, **U.S. Registration 1,772,587**.

4. The mark was registered to Chiquita Brands, Inc. ("Chiquita").

5. On or about July 6, 1999, Chiquita assigned the mark to Roberts & Oake, Inc., a Kentucky corporation and the assignment was recorded in the Trademark Office on or about August 2, 1999 at Reel: 1938; Frame: 0392.

6. Roberts & Oake, Inc., an Illinois corporation, subsequently merged into R & O Transportation LLC, a Delaware limited liability company, on or about December 6, 2002, and the merger documents were recorded in the Trademark Office on or about January 10, 2005 at Reel: 2657; Frame: 0355.

7. In the Assignment, from Chiquita to Roberts & Oake, Inc., Roberts & Oake, Inc. was mistakenly referred to as a Kentucky corporation, when in fact it was an Illinois corporation.

8. The subsequent merger document merging Roberts & Oake, Inc. into R & O Transportation LLC correctly referred to Roberts & Oake, Inc. as an Illinois corporation.

5. This affidavit is filed pursuant to Trademark Manual of Examining Procedure §503.06(b) to correct the inadvertent erroneous reference in the original assignment and cover sheet that was recorded in the United States Patent and Trademark Office at Reel: 1938, Frame: 0392.

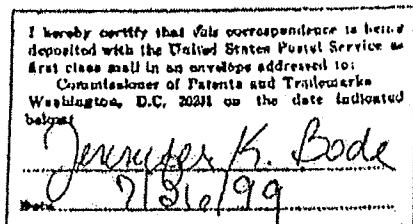
