TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), dated as of February 23, 2013, is entered into by and between Hewlett-Packard Development Company, L.P., a Texas limited partnership, having an address of 11445 Compaq Center Drive West, Houston, TX, 77070 on the one hand (the "Assignor"), and Zenith Electronics LLC, a Delaware limited liability company, having an address of 2000 Millbrook Drive, Lincolnshire, IL 60069, on the other hand ("Assignee").

RECITALS

A. Assignor has adopted, is using and is the owner of all right, title, interest, and goodwill in and to the trademarks listed on Schedule A attached hereto (the "Marks"); and

B. Hewlett-Packard Company and Assignee have entered into an Asset Purchase Agreement, dated as of February 23, 2013 (the "Asset Purchase Agreement"), pursuant to which Hewlett-Packard Company has agreed to, and to cause each of its Affiliates (as defined in the Asset Purchase Agreement) to, assign, sell and transfer each of the Marks unto Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, Assignor does hereby assign, sell and transfer unto Assignee, all of the right, title and interest in and to the Marks, together with (i) the registrations and applications for the Marks, (ii) the goodwill of the business symbolized by and associated with the Marks and (iii) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all infringement or dilution of or damage or injury to the Marks or the registration thereof or such associated goodwill from and after the date hereof. Assignors do further consent to the recordation of this Assignment with any governmental agency.

Assignor agrees, without further consideration, to execute all oaths, assignments, powers of attorney, applications, and other papers necessary or desirable to fully secure to Assignee the right, title and interest conveyed herein, and to take such further actions as may be reasonably requested by Assignee in order to carry out the provisions and purposes of this Assignment including, without limitation, to execute one or more further assignments covering the Marks in a form acceptable for recordation in both the United States Patent and Trademark Office and in foreign trademark offices.


