RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of April 29, 2013 (“Effective Date”) by and between Dex Media West, Inc. (f/k/a Dex Media West LLC), a Delaware corporation, located at located at 1001 Winstead Drive, Cary, North Carolina 27513 (the “Grantor”), and JPMorgan Chase Bank, a New York banking corporation, located at 270 Park Avenue, New York, New York 10017 (the “Collateral Agent”).

WHEREAS, pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement dated as of September 9, 2003 (as amended, supplemented, waived or otherwise modified from time to time, the “Collateral Agreement,” all capitalized terms used, but not defined, herein have the definition assigned to them in the Collateral Agreement), among Grantor, the Lenders, Collateral Agent and certain other parties, Grantor pledged and granted to Collateral Agent a security interest in, to and under the Article 9 Collateral, including, without limitation, the United States trademark registrations, trademark applications and licenses set forth on Schedule A attached hereto, in each case together with the goodwill associated therewith (collectively, the “Trademark Collateral”); and

WHEREAS, the Collateral Agreement was recorded with the United States Patent and Trademark Office on October 6, 2003 at Reel 2832, Frame 0485.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without recourse and without representation and warranty, Collateral Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Trademark Collateral and (ii) terminates the Collateral Agreement as it applies to the Trademark Collateral.

Collateral Agent shall take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.

Collateral Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks to record this Release.
