**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of April 29, 2013 (“Effective Date”) by Deutsche Bank Trust Company Americas, a United States chartered bank, located at 60 Wall Street, New York, New York 10005, as Administrative Agent (the “Administrative Agent”) in favor of R.H. Donnelley Inc., a Delaware corporation, located at 1001 Winstead Drive, Cary, North Carolina 27513 (the “Borrower”).

**WHEREAS**, the Borrower and the Administrative Agent have entered into that certain Second Amended and Restated Guarantee and Collateral Agreement, dated as of December 13, 2005 (as amended and restated or otherwise modified from time to time, the “Collateral Agreement”);

**WHEREAS**, pursuant to the Collateral Agreement, the Borrower and the Administrative Agent entered into that certain Grant of Security Interest in Trademark Rights, dated as of January 17, 2006 (the “Trademark Security Agreement”; all capitalized terms used, but not defined, herein have the definition assigned to them in the Trademark Security Agreement);

**WHEREAS**, pursuant to the terms and conditions of the Trademark Security Agreement, the Borrower pledged and granted to the Administrative Agent a continuing security interest in, and a right of setoff against, the Collateral (including, without limitation, the United States trademark registrations and trademark applications set forth on Schedule A attached hereto), in each case, together with the goodwill associated therewith (collectively, the “Trademark Collateral”); and

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 27, 2006 at Reel 3235, Frame 0768.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without recourse and without representation and warranty, the Administrative Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (ii) terminates the Trademark Security Agreement.

The Administrative Agent shall take all further actions, and provide to the Borrower, the Borrower’s successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Borrower to more fully and effectively effectuate the purposes of this Release.

The Administrative Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks to record this Release.
